

Directions to Site:

I-81 to Exit 57 (PA Route 114); proceed north on Route 114 approximately 1 mile. At the signal light at the intersection of Routes 114 and 944 (Wertzville Road) go straight, take the second right past the signal turn in the lot. The OTCH building is the cream-colored building with a green stripe behind the Rite Aid Pharmacy.

Setting your GPS device to the street address is pretty reliable:

(Call to verify dogs are still accepted; ask when reserving or checking in if a discount is offered for OTCH events.)

The Fairfield Inn, 503 Winding Creek Blvd, Mechanicsburg, PA 17050. Very new and within 5 minutes of OTCH on Rt 114! They are offering anyone who **says they are showing with OTCH** a rate of \$75/night with their dogs. (Otherwise, dogs are not allowed.)

Holiday Inn Express (4.4 mi. from trial site) 6325 Carlisle Pike, Mechanicsburg, PA 17050; (717) 790-0924. **Mention OTCH** for a price of \$92.65 (with tax) and only one dog charge; free breakfast included. Directions: from the hotel, turn right onto US11 West, go 1.4 miles, turn right on Route 114. More directions below.

Hampton Inn Carlisle (7 miles from the trial site) 1164 Harrisburg Pike, Carlisle, PA 17013 (717) 240-0200 Directions: From I-81 North - Take Exit 52B and make a right, go about one mile and the hotel is on the right-hand side. From I-81 South - Take Exit 52 and make a right, go about one mile and the hotel is on the right-hand side. From PA Turnpike - Take Exit 226, continue straight, north towards Harrisburg hotel is across from exit ramp on the left. You will be able to see the hotel from the exit ramp, but you may not make a left-hand turn from the traffic light, turn right in the Pilot Travel parking lot - go through lot make left out of lot and go straight through light.

Parking at the site: Our lot is paved and large; parking is available on Souder Court.

Entrance and Crating Area: Access to the building will be at 7:30 a.m. and check-in is at 8:00 a.m. Use the side entrance by Rite Aid. Limited crating with social distancing is in the small ring.

Lunch will not be available. OTCH is a non-smoking building.

Please, clean up after your dog! There is ample walking area around our building and through the neighborhood and we have clean-up bags and trash cans outside our door and on the hill behind the building. Please, use them!

We welcome you to our Rally and Obedience Trials and hope you will have a fun and successful weekend!

OTCH will follow any COVID-19 guidelines in place at the time of the trials. If you don't feel well, STAY HOME! We will shred your check.

If entry limit is reached before entries close, a wait list will be established. The trial secretary will accept class move ups (requested by US mail or email) for Saturday no later than Saturday, **Oct. 1, 2022**.  - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.**
