This seminar is to give an overview of UKC Rally Obedience for exhibitors who wish to know more about the sport and better prepare themselves and their dogs for enjoyable and successful competition.

Objectives

- Overview of UKC Rally-Obedience and its rules
- The differences between UKC and AKC Rally Obedience
- Eligibility requirements for entering the different UKC Rally levels and classes, including A versus B classes in all levels as well as the C class found only in RO1
- Explain how to complete a UKC performance event entry form, including selecting minimum or standard jump heights
- Titles and championships and how they are earned
- Requirements for earning All-Star Points, All-Star Standings, and year-end rankings
- Practicing on a Rally course
- Provide an explanation of how points are lost and how many points are lost for particular errors, such as crooked sits versus retries of an exercise
- A judge's discretionary use of saying "fault" on a handler's error
- Provide an explanation of errors that will result in a non-qualifying score

 - If you order a printed copy from UKC, it's a bit expensive and they don't bind it for you.
 - Office supply stores like Staples or Walmart can do same-day printing.
 - Some online companies may have a better price and a good turnaround time.
