NO REFUNDS AFTER CLOSE OF ENTRIES

A \$5.00 handling fee will be deducted from the refund of entries that are withdrawn prior to the closing date.

Returned checks do not constitute a valid entry. There will be a \$30.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within seven (7) days of notice to exhibitor of returned check. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is cancelled without recourse by owner/handler.

 - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.**
